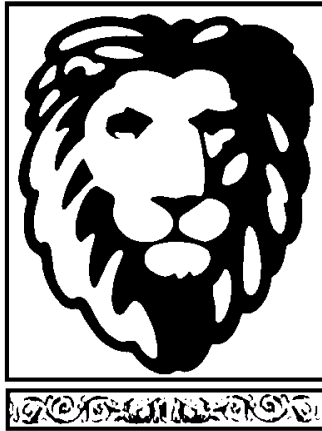

General Conditions of Membership

1. The Club shall have the absolute right to designate persons who are eligible for membership and who shall have the right to use any or all of the facilities of the Club, upon such terms and conditions as determined from time to time by the Club. Eligibility for membership shall not be based on grounds of sex, race, color or national origin.
2. Membership in the Club is a revocable license only. Applicant Member agrees to comply with and be bound by the Epping Forest Yacht Club Bylaws, Rules and Regulations as they now exist or may from time to time hereafter be amended or supplemented. The complete rules and regulations handbook can be found in the membership office.
3. Club bills are due and payable upon receipt. Bills past due in excess of 30 days will be considered cause for suspension and a service charge of 1-1/2% per month (18% annual percentage rate) will be applied on past due amounts. A \$150.00 reinstatement fee shall be required if a membership is suspended for failure to pay bills past due. In addition to suspension of membership, failure to pay dues and/or club accounts will result in expulsion if suspension of the membership occurs two times during the year. Members will also be liable for all costs and expenses of any legal action to collect accounts properly owed to the Club.
4. In the Club's sole discretion, membership may be suspended or canceled, without refund, if a Member or a Member's guest: (a) Violates Club rules and policies including the Membership Agreement, Member's Handbook, or the Governor's Club rules; (b) Violates any state, federal, or municipal law, regulation or ordinance while on Club property or during any Club-sponsored event, or (c) Engages in any wrongful, intentional, or negligent conduct or otherwise acts in any wrongful manner which may expose the Club to liability or is inappropriate or inconsistent with the Club's policies.
5. Membership cards are not transferable and may be used only by the member and eligible dependents. Loaning of membership cards is not permitted and may result in cancellation of membership. Membership cards must be presented when using Club Facilities. Guests of a member must be accompanied by the member when using the Club unless prior authorization is granted by the Membership Department.
6. Initiation fees and dues are non-refundable and are not transferable, and subject to appropriate sales tax. Membership is not an investment in the Club. It does not provide an equity or ownership interest in the Club or any of the Club Facilities.
7. The Membership Department must be notified immediately of any change of status to membership. This includes adding/removing a spouse as a result of marriage or divorce, additional dependents, death of a member, employment changes, residence or phone numbers.
8. All membership categories extend privileges to the member, spouse and dependents under the age of 23. In the event of a divorce, the membership is decreed by court order. The remaining party may apply for his/her own membership within 60 days after divorce at 50% of current initiation fee.
9. Members under the age of 35, qualify for a Commander membership (based on the oldest spouse, if married). A driver's license(s) must be submitted for proof of age. Commander members pay half of the initiation fees initially, with the balance due upon turning age 35. Commander members turning age 35 will be upgraded to a Captain membership, at which time, dues will also upgrade to Captain dues.
10. Applicant member covenants and agrees to release, waive, indemnify and hold harmless the Club and its directors, officers, employees, representatives, affiliates and agents, from any and all loss, cost, claim, injury, damage, action or liability sustained or incurred by him/her or his/her family or guests, resulting from any act or omission of any director, officer, employee, representative, affiliate or agent of the Club or arising out of or incident to memberships in the Club and/or use of the Club's facilities.
11. The Club will not be responsible for loss or damage to property of Members or their Guests on the Club's property.
12. It is understood that a member may resign from the Club by giving thirty (30) days advance written notice to the Club and by paying any outstanding dues and charges incurred prior to termination. It is further agreed, however, that a member may not offset dues or charges against the initiation fee.
